

Regional CLTA Affiliation Proposal, August 2010, revised Sept 2010 based on CLTA Board feedback. The Board Voted to Approve

**Regional CLTAs who wish to affiliate with the national CLTA organization will follow the following procedure on an annual basis:**

1. The President or other designated officer of the regional association contacts the national CLTA Executive Director, providing the following information: (which we need to decide upon: officers, contact info, location, membership profile, by-laws or constitution, mission statement, website URL, etc.)

2. The Regional Association pays a \$100 annual affiliation fee to affiliate with CLTA.

**Affiliated Regional CLTAs have the following privileges:**

- Officially affiliated regional CLTAs will be listed on the CLTA website with a link to their own websites.
- Officially Affiliated Regional CLTAs are contacted annually by the CLTA Nominations committee and invited to submit nominations for candidates to the CLTA Board. *Nominees must be current members of the national CLTA* and nominations must be accompanied by a resume or a CV describing the qualifications of the nominee. The CLTA Nominations Committee considers these nominations along with nominations it receives from the CLTA Board and CLTA members as it prepares a slate of candidates for the CLTA Board.

Regional CLTAs officially affiliated with the national CLTA are eligible to apply for support from the national CLTA for regional conferences and workshops. Support will be awarded as funds allow based on the merit of the proposal.

**Additional Details of Affiliation:**

- Regional members are encouraged but are not required to join the national CLTA.
- Members of regionals *who are not members of CLTA national* cannot vote in national CLTA elections, are not eligible for the discounted CLTA members registration fee at the ACTFL/CLTA annual meeting, cannot submit a proposal for the CLTA Annual Meeting, and are not eligible to access 'members-only' areas of the CLTA website.
- Regional CLTAs are solely responsible for their fiscal operation and legal and insurance obligations.

- 向本学会申请经费资助，举行地区性学术会议及活动。本学会将根据所提申请之内容加以决定。
